Hundreds Arrested in World's Largest Ever Pedophile Ring Raid

Hundreds of child rapists have been arrested around the world in one of the biggest international pedophile ring raids in history.

Law enforcement discovered sickening child rape imagery including "imagery depicting sadistic acts of sexual abuse of infants and children" after an online service provider reported in 2019 that their services were being use to share images of child sexual

abuse, [according](#) to a press release from Europol. The investigation so far has led to the opening of 836 cases and the safeguarding of 146 children internationally, the press release said. Police identified more than 100 suspects across the EU and arrested 46 in New Zealand according to the press release.

New Zealand authorities led the investigation, aided by the U.S., U.K., Canada, Australia and several European countries.

"This operation will have an impact on the global networks that deal in the most horrific and damaging material, and we are extraordinarily proud of the effect it will have on children's lives around the world," said Tim Houston, who led the operation at the Department of Internal Affairs in New Zealand, [according](#) to The New York Times.

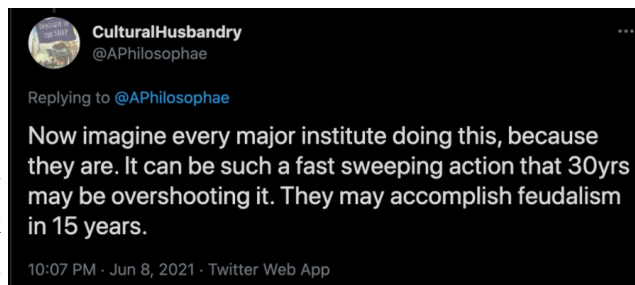

Homebuyers in the United States have found difficulties acquiring single-family homes after the year-long business shut-downs and lockdowns that followed Covid-19. It seems there's a new wave of homebuyers in the U.S. real estate market, with buyers stemming from hedge funds, pension funds, clearinghouses, and financial services companies. The weight of real estate property under the U.S. banking system's wings today has analysts and economists very concerned about the next financial crisis.

While the U.S. government and the Federal Reserve have told American citizens the nation's economy is hunky-dory, investigators looking at statistics know something is not right. The public is well aware that the U.S. central bank increased its monetary supply more in 2020 than any year prior in the country's

Investigative reports and data now show that the M1 expansion found its way into the U.S. real estate market and the banking cartel has captured a lot of property during the last year. Despite a few reverse repos, mortgage-backed securities (MBS) are being held tight by the Federal Reserve. In fact, as of June 2, 2021, the U.S. central bank owns 21% of all the mortgage bonds in America. Stats show the Fed purchased more than \$100 billion per month in MBS from lenders and mega banks.

“The Fed has been aggressively buying MBS (mortgage-backed securities). Another clear example of how artificially pumping liquidity in an assets creates bubbles and issues down the line. This is not healthy,” the macroeconomic and commodities strategist Gianluca said at the end of May. The Federal Reserve’s own statistical data shows the American central bank owns around \$2.273 trillion in MBS.

Well before Covid-19 made headlines in the U.S., central banks worldwide invoked massive monetary easing policy changes. Alongside this, well before Covid-19, the Federal Reserve and Wall Street banks were buying up retail and commercial properties in the form of mortgage-backed securities. Financial columnist Joy Wiltermuth from Marketwatch, reported on the Fed’s MBS purchases back in November 2019 when the bank was buying around \$30 billion a month in MBS.

Wiltermuth stated that “the Fed’s goal is to eventually shed its MBS holdings,” but instead of shedding MBS, the central bank tripled its real estate buying. “What if banks are becoming insolvent due to a year of mortgages not getting paid,” Tim Pool asked his Twitter followers the next day. “Someone will have to bail them out,” the journalist added.

ONE IN EVERY TEN COLORADO VOTERS IMPACTED: MASSIVE IRREGULARITIES IN THE 2020 ELECTION CONFIRMED BY CITIZEN-LED CANVASSING EFFORT

Generated after months of volunteer voter canvassing to verify state public election records, The USEIP Colorado Canvassing Report exposes massive irregularities, anomalies, and numerous law violations.

[Denver, Colorado, March 10, 2022] – [A report](#) published today by the U.S. Election Integrity Plan (USEIP) found that hundreds of thousands of Colorado voters were impacted by election irregularities and anomalies in the 2020 elections. The report analyzed canvassing records from multiple Colorado Counties. Volunteers went door-to-door verifying public voting records. The election data that was verified is public, maintained by Colorado Secretary of State Jena Griswold.

Professional statisticians, mathematicians, retired military officers, software engineers, and corporate training specialists came together on a completely volunteer basis to design the canvassing program from start to finish. The peer-reviewed, statistical sampling method used for the canvassing was designed so that results can hold up in court. This strict and rigorous approach produced statistical significance in the canvassed counties. More importantly, it allows for statistically sound assertions on voting irregularities to be made for the state as whole. Those assertions are stunning. Extrapolating the canvassed county findings to the entire state, **the number of impacted voters in Colorado is between 210,091 and 462,201.**

The USEIP report exposes shocking types of widespread problems with the Colorado election system. A sample of the top irregularities in the report include:

1. **Fake voters.** The voter did not cast a ballot, but County Clerk and Recorder and Secretary of State managed records show a ballot was cast in the voter’s name.
2. **Lost votes.** The voter did cast a ballot but records show no ballot was cast.
3. **Illegal votes.** The voter did not live at the address indicated at the time of the 2020 election.
4. **Voter data manipulation.** The voter’s party affiliation changed without their authorization.

Voter database manipulation. The voter did not reside at the documented address in the voter database at the time of canvassing, but months after canvassing the voter was registered at the same address in the voter registration database.

Explaining or rationalizing these anomalies and irregularities will be extremely difficult for elected officials. It’s anticipated that county clerks, commissioners, and Secretary of State Jena Griswold will dismiss the Colorado canvassing report with flimsy excuses like *the anomalies are not widespread, or no election is completely without some irregularities, or clerical errors can happen due to data and record transferring between databases.*

Unfortunately, the data is overwhelming in USEIP’s Colorado Canvassing Report. The findings obliterate tired excuses historically used for dismissing objective evidence and dodging responsibility.

It’s anticipated election officials will shift blame to the public, claiming voters *don’t understand how elections work*, to dismiss legitimate public concerns. In fact, Secretary Griswold is joined by Executive Director of the Colorado County Clerks Association Matt Crane, numerous Colorado clerks, including Carly Koppes (Weld), and Chuck Broerman (El Paso), in parroting the tired and inaccurate trope, “Colorado’s elections are the gold standard!”

Clerk Broerman went so far as proudly claiming his voter rolls in El Paso are “pristine” after the 2021 local elections. In that same election, in cooperation with Secretary Griswold, El Paso’s election results were manually changed after a discrepancy was discovered between the state and county-reported results. The Colorado Canvassing Report exposes El Paso County as having an anomaly / irregularity rate ranging from 7.5% to 13.5%. This translates to a range of 54,359 to 69,829 El Paso County voters.

“The 2020 voter data told a story. We found patterns in the data which signaled the results in Colorado’s 2020 election had serious, unexplained problems. The only way to unequivocally verify what we saw was to manually verify the publicly available information from the voters themselves. What this report proves is shocking. Every voter and elected official needs to immediately take action to investigate in order to understand how to fix our obviously broken election system.” States Jeff Young, the chief author of the report.

Given the slim margins deciding local races and measures, numerous elected officials and counties in the state have been impacted. There are many [legal cases](#) that serve as [precedent](#) for remedying illegal elections. In fact, it’s surprisingly common to have elected [officials removed from office](#) even [after they’ve taken office](#), and after more than a year has passed since the certification of the race.

This should give Colorado voters confidence that they do not have to live with election results that have not been verified to their satisfaction to be error-free and legitimately run. Election officials have balked in the face of concerns presented by voters since election

In Dugway's first few decades, the base worked mostly on offensive weaponry: biological and chemical munitions designed to directly attack enemies.

Clip: Sampling devices, positioned throughout the test area, yield valuable information to chemical core researchers.

Narrator: The 1950s, for example, saw the launch of Operation Big Itch, an experiment that was testing weaponized fleas. The fleas weren't infected with any type of disease or agent, but experimenters were working with thousands of them. And the fleas were dropped in cluster bombs, to gauge if they would survive the fall from an airplane. And this was only part one. Dugway launched a second experiment, called Project Bellwether, in the 1960s.

Only this time, mosquitoes were injected with inert diseases, inert bacteria, and inert viruses. But get this: Those mosquitoes were released upon several groups of human volunteers, who were bitten again and again during the trials.

And there are records dating back to the late 1950s, which describe experiments that used infected mosquitoes. And those are just two experiments known to the public. Exactly what goes on at Dugway is, well, pretty unclear. And that's not by accident.

The area is intensely guarded. Everything that comes in and out is carefully monitored, guards are on constant patrol and actively armed, and the perimeter is lined with tall, barbed-wire fencing. There are even signs that authorize "deadly force" when necessary. Since the 1940s, officials say operations have

shifted from offensive to defensive tactics. Case in point, most of the current known work prepares agents to defend against potential biological and chemical attacks. For example, a multitude of training programs are held on-site for the armed forces.

Here's one in which Army Reserve soldiers are tasked with checking the radiation levels of artillery rounds. And here's another where soldiers were tasked with identifying substances in a simulated chemical lab.

Dugway's main operations include the "BRAUCH" training facility, constructed from various shipping containers. It simulates underground environments for military training. There are also various buildings and rooms that serve specific purposes. Like the decontamination testing chamber, the wind-tunnel testing room, and the material test facility.

But perhaps the most interesting room of all is this: the Smartman Laboratory facility, which houses the Smartman dummy, a model that's used to simulate human contact with chemical agents, including the infamous VX nerve agent. Specifically, the Smartman helps the lab develop more effective individual protection respiratory equipment,— essentially, gas masks and the like.

Narrator: In 1968, about 6,000 sheep died near this government facility. They were poisoned by a chemical weapon named VX.

The US hasn't been known to actively use VX in combat. In fact, it's begun destroying its stockpile of chemical munitions as part of a UN treaty. But it's just one of many strange and secretive experiments that happened within these walls. Experiments on sheep, mosquitoes, and even civilians.

About 85 miles southwest of Salt Lake City is the US government's top-secret bioweapons lab. It's called the Dugway Proving Ground. The 77-year-old facility covers about 800,000 acres. That's just a little larger than the entire state of Rhode Island. And it tests some of the deadliest chemical, biological, radiological, and explosive hazards on Earth.

Less famous than Area 51, Dugway dates all the way back to 1942. Right in the middle of World War II.

Clip: The decisive battle of war has begun.

Narrator: The government needed a large area to test powerful weapons, eventually settling on this stretch of land in the Utah desert. Back then, the site was used to test everything from chemical sprays and flamethrowers to various antidotes and protective equipment, and even fire-bombing.

After World War II, Dugway mostly shut down. Until the Korean War began in 1950. That's when the proving ground turned into what it is today: a permanent military base.

Dugway Proving Ground tests and stores some of the deadliest chemical and biological agents on Earth.

Past experiments include weaponized mosquitoes and fleas, as well as tests with deadly diseases such as anthrax.

cluding ABC, CBS, and NBC, as well as cable TV news stations Fox News, CNN, and MSNBC, legacy media publications including the New York Post, the Los Angeles Times, and the Washington Post, digital media companies like BuzzFeed News and Newsmax, and hundreds of local newspapers and TV stations.” The Blaze’s story notes. “These outlets were collectively responsible for publishing

There was a complete lack of transparency from the pharmaceutical companies, the Food and Drug Administration, and the media outlets that promoted these vaccines.

“Though virtually all of these newsrooms produced stories covering the COVID-19 vaccines, the taxpayer dollars flowing to their companies were not disclosed to audiences in news reports, since common practice dictates that editorial teams operate independently of media advertising departments and news teams felt no need to make the disclosure,” as some publications The Blaze reached for comment explained.

Who is Klaus Schwab? The 'Great Reset' is no conspiracy theory

The idea of a "Great Reset" can be traced back to 1971, when Klaus

Schwab founded the European Management Forum, now known as the World Economic Forum (WEF).

Last year, Schwab and Thierry Malleret, co-founder and main author of the Monthly Barometer, published a book called "COVID-19: The Great Reset". In the book, they define the Great Reset as a means of addressing the "weaknesses of capitalism" that were purportedly exposed by the Covid pandemic, Michael Rectenwald, Chief Academic Officer of American Scholars, said in a speech [published last month](#) by Hillsdale College's Imprimis.

Thus, far from being a conspiracy theory, "The Great Reset is real," according to Rectenwald.



That said, conspiracy theories about the "Reset" abound including the widely-held assumption that it was to have begun with the election of Hillary Clinton as president in 2016.

Schwab had argued in a 1971 book "that the management of a modern enterprise must serve not only shareholders but all stakeholders to achieve long-term growth and prosperity."

"All stakeholders" could mean the entire human race or it could refer to those deemed worthy, i.e., the elite members of what comedian George Carlin referred to as the "Club."

In an often-quoted monologue, Carlin referred to a rigged system: "It's a big club and you ain't in it."

Schwab and the WEF — an organization made up of the world's political, economic, and cultural elites that meets annually in Davos, Switzerland — "have promoted the idea of stakeholder capitalism ever since. They can take credit for the stakeholder and public-private partnership rhetoric and policies embraced by governments, corporations, non-governmental organizations, and international governance bodies worldwide," Rectenwald said.

Rectenwald, the author of numerous books, has taught at New York University, Duke University, North Carolina Central University, Carnegie Mellon University, and Case Western Reserve University.

The following is adapted from his talk delivered at Hillsdale College on Nov. 7, 2021, during a Center for Constructive Alternatives conference on "The Great Reset":

The specific phrase "Great Reset" came into general circulation over a decade ago, with the publication of a 2010 book, *The Great Reset*, by American urban studies scholar Richard Florida. Written in the aftermath of the 2008 financial crisis, Florida's book argued that the 2008 economic crash was the latest in a series of Great Resets — including the Long Depression of the 1870s and the Great Depression of the 1930s — which he defined as periods of paradigm-shifting systemic innovation.

Four years after Florida's book was published, at the 2014 annual meeting of the WEF, Schwab declared: "What we want to do in Davos this year . . . is to push the reset button" — and subsequently the image of a reset button would appear on the WEF's website.

In 2018 and 2019, the WEF organized two events that became the primary inspiration

for the current Great Reset project ...

In May 2018, the WEF collaborated with the Johns Hopkins Center for Health Security to conduct "CLADE X," a simulation of a national pandemic response. Specifically, the exercise simulated the outbreak of a novel strain of a human parainfluenza virus, with genetic elements of the Nipah virus, called CLADE X. The simulation ended with a news report stating that in the face of CLADE X, without effective vaccines, "experts tell us that we could eventually see 30 to 40 million deaths in the U.S. and more than 900 million around the world—twelve percent of the

global population." Clearly, preparation for a global pandemic was in order.

In October 2019, the WEF collaborated with Johns Hopkins and the Bill and Melinda Gates Foundation on another pandemic exercise, "Event 201," which simulated an international response to the outbreak of a novel coronavirus. This was two months before the COVID outbreak in China became news and five months before the World Health Organization declared it a pandemic, and it closely resembled the future COVID scenario, including incorporating the idea of asymptomatic spread.

The CLADE X and Event 201 simulations anticipated almost every eventuality of the actual COVID crisis, most notably the responses by governments, health agencies, the media, tech companies, and elements of the public. The responses and their effects included worldwide lockdowns, the collapse of businesses and industries, the adoption of biometric surveillance technologies, an emphasis on social media censorship to combat "misinformation," the flooding of social and legacy media with "authoritative sources," widespread riots, and mass unemployment.

A variety of chemists, chemical analysts, and technicians work on-site. And the use of airtight chambers and gas masks is not only common, but mandatory. Despite all of this dangerous experimentation, the work done at Dugway hasn't always been properly contained.

Remember that sheep incident? That marked the start of a worrisome track record. It happened when overhead planes spewed out the nerve agent into the wind, accidentally sending it into nearby farmland in Skull Valley. Within the next couple of days, farmers found thousands of sheep dead in their fields. The Army compensated the farmers and lent them bulldozers to bury the sheep. But the accident sparked a whole debate on the use of chemical weapons in warfare.

Adding on to these questionable practices, a 1994 Senate hearing on veterans' health focused specifically on Dugway veterans and civilians. A report found that people at Dugway were exposed to biological and chemical simulants believed to be safe at the time, but that the Army had later stopped using many of them because "they realized they were not as safe as previously believed."

One veteran, who was accidentally sprayed in the face with the chemical DMMP in 1984, found himself wheezing and coughing the next day — symptoms that ended up lasting several weeks. Despite this, he was given only cough medicine and antibiotics by the Dugway Army Hospital. The Dugway Safety Office assured him that the chemical was safe. But by 1988, officials at Dugway had reevaluated the simulant's danger and were concerned it could cause cancer and kidney damage.

In 2011, the facility slipped up again: It went on lockdown after workers lost a vial con-

taining the VX nerve agent. Nobody was permitted to enter or exit the facility, not even the employees.

And in 2016, the CDC and the Department of Defense launched a major investigation when a review team found that Dugway had been operating dangerously for several years without the government's knowledge. USA Today reported "egregious failures" by the facility's leadership and staff. The reports singled out the head colonel in command at Dugway, Brig. Gen. William King.

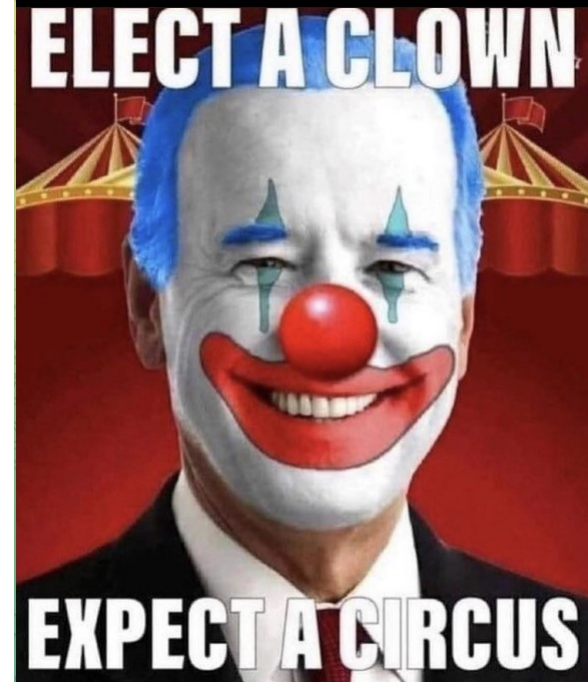

to effectively oversee biosafety procedures crucial to Dugway's operation. The report admonished him, saying he "repeatedly deflected blame" and "minimized the severity of incidents." It even says King "fails to recognize" how serious the incidents truly were. And how serious were the incidents, exactly? Well, under King's command, the facility mistakenly shipped live anthrax to other labs. And not just once, but multiple times. For over a decade.

That same report revealed that workers had been regularly and deliberately manipulating data in important records. Records meant to verify that pathogens being transported elsewhere were killed and safe for researchers to handle without protective gear. Still, the facility's shady past, secretive operations, and intense surveillance have captured the attention, and skepticism, of some closer observers, including several conspiracy-theorist groups.

There are suggestions that the facility is the "new Area 51." And the local community has raised their own questions about the facility's operations. Dugway was even featured in an episode of The History Channel's "UFO Hunters," in which local residents and UFO watchers were interviewed and footage from the area was examined. It's hard not to wonder, when you live in close proximity to such a restricted landscape.



Despite these theories, Dugway has expressed a desire to be "more transparent." And representatives have said the facility wants to be "more a part of the local community" by better informing citizens about what exactly goes on there. So far, they've delivered some on that. The facility has its own events page, which lists several events open to the general public and the local Utah community. This year, they're hosting a trail race on the facility grounds.

Certainly, today's Dugway is a far cry from the 1940s Dugway, which was entirely closed off to the public. But despite the shift in the level of secrecy, much of Dugway's testing remains classified, preserving the skepticism and mysteriousness surrounding the facility.

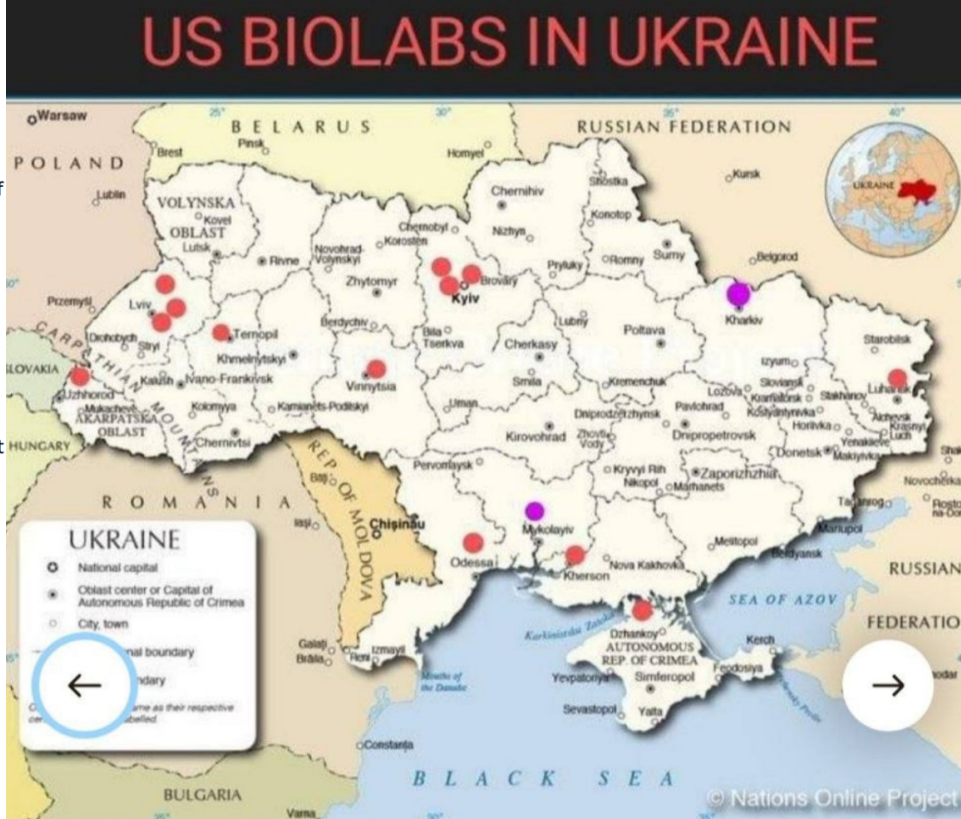

In addition to being promoted as a response to COVID, the Great Reset is promoted as a response to climate change. In 2017, the WEF published a paper entitled, “We Need to Reset the Global Operating System to Achieve the [United Nations Sustainable Development Goals].” On June 13, 2019, the WEF signed a Memorandum of Understanding with the United Nations to form a partnership to advance the “UN 2030 Agenda for Sustainable Development.” Shortly after that, the WEF published the “United Nations-World Economic Forum Strategic Partnership Framework for the 2030 Agenda,” promising to help finance the UN’s climate change agenda and committing the WEF to help the UN “meet the needs of the Fourth Industrial Revolution,” including providing assets and expertise for “digital governance.”

In June 2020, at its 50th annual meeting, the WEF announced the Great Reset’s official launch, and a month later Schwab and Malleret published their book on COVID and the Great Reset. The book declared that COVID represents an “opportunity [that] can be seized”; that “we should take advantage of this unprecedented opportunity to reimagine our world”; that “the moment must be seized to take advantage of this unique window of opportunity”; and that “[f]or those fortunate enough to find themselves in industries ‘naturally’ resilient to the pandemic”—think here of Big Tech companies like Apple, Google, Facebook, and Amazon—“the crisis was not only more bearable, but even a source of profitable opportunities at a time of distress for the majority.”

The Great Reset aims to usher in a bewildering economic amalgam—Schwab’s stakeholder capitalism—which I have called “corporate socialism” and Italian philosopher Giorgio Agamben has called “communist capitalism.”

In brief, stakeholder capitalism involves the behavioral modification of corporations to benefit not shareholders, but stakeholders—individuals and groups that stand to benefit or lose from corporate behavior. Stakeholder capitalism requires not only corporate responses to pandemics and ecological issues such as climate change, “but also rethinking [corporations’] commitments to already-vulnerable communities within their ecosystems.” This is the “social justice” aspect of the Great Reset. To comply with that, governments, banks, and asset managers use the Environmental, Social, and Governance (ESG) index to squeeze non-woke corporations and businesses out of the market. The

ESG index is essentially a social credit score that is used to drive ownership and control of production away from the non-woke or non-compliant.

Another way of describing the goal of the Great Reset is “capitalism with Chinese characteristics”—a two-tiered economy, with profitable monopolies and the state on top and socialism for the majority below.

Several decades ago, as China’s growing reliance on the for-profit sectors of its economy could no longer be credibly denied by the Chinese Communist Party (CCP), its leadership approved the slogan “socialism with Chinese characteristics” to describe its economic system. Formulated by Deng Xiaoping, the phrase was meant to rationalize the CCP’s allowance of for-profit development under a socialist political system. The CCP considered the privatization of the Chinese economy to be a temporary phase—lasting as long as 100 years if necessary—on the way to a communist society. Party leaders maintain that this approach has been necessary in China because socialism was introduced too early there, when China was a backward agrarian country. China needed a capitalist booster shot.

Stripped of its socialist ideological pretensions, the Chinese system amounts to a socialist or communist state increasingly funded by capitalist economic development. The difference between the former Soviet Union and contemporary China is that when it became obvious that a socialist economy had failed, the former gave up its socialist economic pretenses, while the latter has not.

The Great Reset represents the development of the Chinese system in the West, but in reverse. Whereas the Chinese political class began with a socialist political system and then introduced privately held for-profit production, the West began with capitalism and is now implementing a Chinese-style political system. This Chinese-style system includes vastly increased state intervention in the economy, on the one hand, and on the other, the kind of authoritarian measures that the Chinese government uses to control its population.

Schwab and Malleret write that if “the past five centuries in Europe and America” have taught us anything, it is that “acute crises contribute to boosting the power of the state. It’s always been the case and there is no reason it should be different with the COVID-19 pandemic.”

As if the economic and governmental resets were not dramatic enough, the technological reset reads like a dystopian science fiction novel. It is based on the Fourth Industrial Revolution—or 4-IR for short.

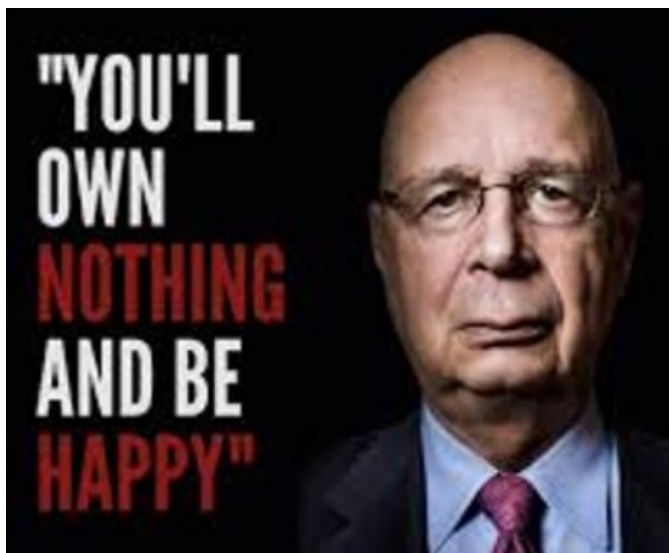
The first, second, and third industrial revolutions were the mechanical, electrical, and digital revolutions. The 4-IR marks the convergence of existing and emerging fields, including Big Data, artificial intelligence, machine learning, quantum computing, genetics, nanotechnology, and robotics. The foreseen result will be the merging of the physical, digital, and biological worlds, which presents a challenge to the ontologies by which we understand ourselves and the world, including the definition of a human being.

There is nothing original about this. Transhumanists and Singularitarians (prophets of technological singularity) such as Ray Kurzweil forecasted these and other revolutionary developments long ago. What’s different about the globalists’ vision of 4-IR is the attempt to

harness it to the ends of the Great Reset.

If already existing 4-IR developments are any indication of the future, then the claim that it will contribute to human happiness is false. These developments include Internet algorithms that feed users prescribed news and advertisements and downrank or exclude banned content; algorithms that censor social media content and consign “dangerous” individuals and organizations to digital gulags; “keyword warrants” based on search engine inputs; apps that track and trace COVID violations and report offenders to the police; robot police with scanners to identify and round up the unvaccinated and other dissidents; and smart cities where residents are digital entities to be monitored, surveilled, and recorded, and where data on their every move is collected, collated, stored, and attached to a digital identity and a social credit score.

In short, 4-IR technologies subject human beings to a kind of technological management that makes surveillance by the NSA look like child's play. Schwab goes so far as to cheer developments that aim to connect human brains directly to the cloud for the sake of "data mining" our thoughts and memories. If successful, this would constitute a technological mastery over decision-making that would threaten human autonomy and undermine free will.

In terms of the social order, the Great Reset promises inclusion in a shared destiny. But the subordination of so-called "netizens" implies economic and political disenfranchisement, a hyper-vigilance over self and others, and social isolation—or what Hannah Arendt called "organized loneliness"—on a global scale. This organized loneliness is already manifest in lockdowns, masking, social distancing, and the social exclusion of the unvaccinated. The title of the Ad Council's March 2020 public service announcement—"Alone Together"—

perfectly captures this sense of organized loneliness.

In my recent book, *Google Archipelago*, I argued that leftist authoritarianism is the political ideology and modus operandi of what I

call Big Digital, which is on the leading edge of a nascent world system. Big Digital is the communications, ideological, and technological arm of an emerging

corporate-socialist totalitarianism. The Great Reset is the name that has since been given to the project of establishing this world system.

Just as Schwab and the WEF predicted, the COVID crisis has accelerated the Great Reset.

Our civilization is now in crisis and on the brink of chaos and dissolution.

Monopolistic corporations have consolidated their grip on the economy from above, while socialism continues to advance for the rest of us below. In partnership with Big Digital, Big Pharma, the mainstream media, national and international health agencies, and compliant populations, hitherto democratic Western states—think especially of Australia, New Zealand, and Austria—are being transformed into totalitarian regimes modeled after China.

But let me end on a note of hope. Because the goals of the Great Reset depend on the obliteration not only of free markets, but of individual liberty and free will, it is, perhaps ironically, unsustainable. Like earlier attempts at totalitarianism, the Great Reset is doomed to ultimate failure. That doesn't mean, however, that it won't, again like those earlier attempts, leave a lot of destruction in its wake—which is all the more reason to oppose it now and with all our might.

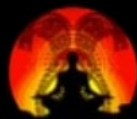

For those of you who have been paying attention to the UK, you'll know why Boris Johnson ended all Covid protocols, mandates, and restrictions overnight without a seconds notice.

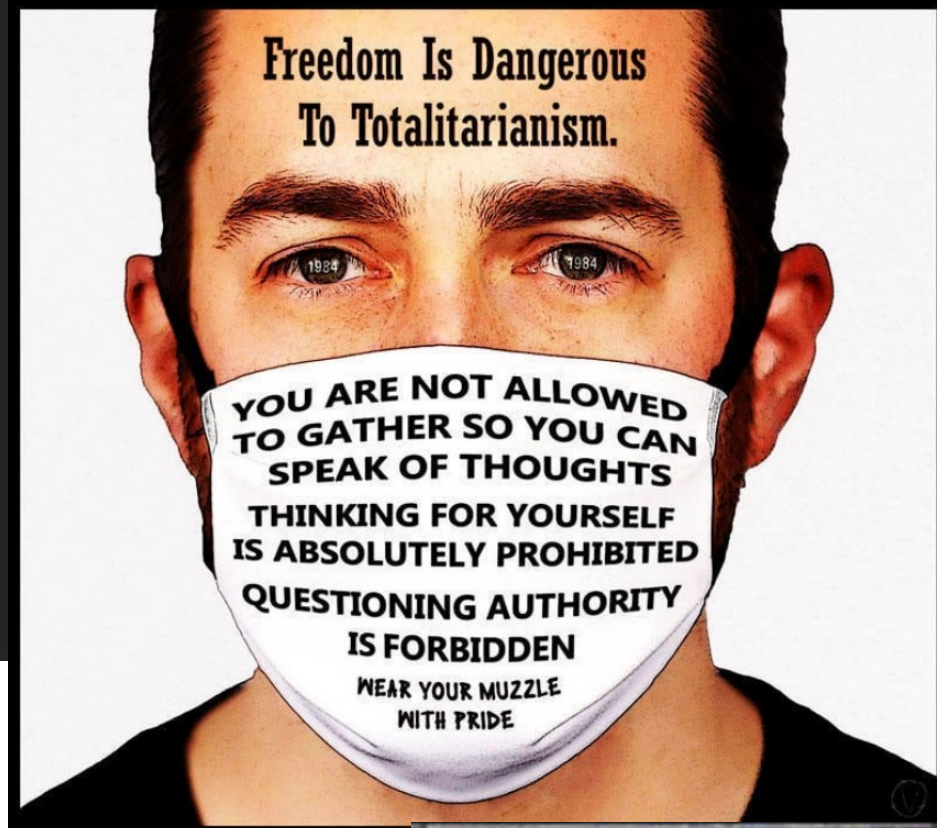

Hunter Biden Firm Rosemont Seneca Invested in Firm Tied to Ukrainian Biolabs By [Joe Hoft](#) March 10, 2022

We heard on Tuesday (3/8/22) from the US State Department that there were US Biolabs in Ukraine. Then on Wednesday the Biden regime backtracked and insisted there were no US-funded Biolabs in Ukraine.

Metabiota publicized its relationship with Black & Veatch in 2018.

The US State Department admitted to having Biolabs in Ukraine on Tuesday in front of the US Senate. Then yesterday the Biden White House claimed these Biolabs in Ukraine were not biological weapons labs.

Today (3/10) we have confirmation that there were Biolabs in Ukraine and Hunter Biden's firm Rosemont Seneca invested in the firms who were building these labs.
